Beautify My Marianas

What is Beautify My Marianas?

Beautify My Marianas enables the community and student groups to raise money for their causes by giving them the opportunity to cleanup designated sites on Saipan, Tinian and Rota. This program raises awareness of the importance of having a clean and safe environment, reduces littering and creates a unique sense of pride in our islands. Beautify My Marianas offers \$100 for each project in an assigned area.

Who is Eligible?

Any established organization, club or a group made up of community members.

What are the responsibilities of a Beautify My Marianas Group?

The group is required to complete the application form and submit to the Marianas Visitors Authority (5) working days or more prior to your scheduled cleanup. You will be contacted by the MVA when your application has been approved with an assigned location.

Groups who fail to complete all requirements within the specified time will not be paid. Payments may be made 30 days after all requirements are completed and approved. All decisions made by the MVA with regard to this program shall be final. The MVA reserves the right to accept or deny any applications at their sole discretion.

In addition, the group agrees to the following:

- Upon signing the application, the group will retain all liability for accidents, injuries, etc., during the cleanup.
- Wear bright clothing, shoes (no open toes), gloves and long pants.
- o Pick up trash ONLY during daylight hours.
- Groups will remove trash from both sides of the roadway or at designated areas.
- Do not pick up dead animals or hazardous materials.
- o Wear protective goggles, especially when operating machinery or equipment.
- The group agrees to obtain all supplies and materials needed for the cleanup.
- The group must properly dispose of garbage collected at the DPW Transfer Station in Lower Base.
- Chemicals and similar items should be reported to the proper authorities.
- When participants are under the age of eighteen (18), the group shall have one (1) adult supervisor for every five (5) minors.

How does an organization apply to participate?

Applications are available at the MVA Main Office on the 1st Floor of Gold Beach Hotel on Beach Rd. in Garapan; at the Tinian MVA Field Office in San Jose; at the Rota MVA Field Office in Songsong; or on our website at www.mymarianas.com. For more information, you may call MVA at 670-664-3200.
